

- 5. That school is not paying any charges towards using name, motto, logo or any other non0academic activities to any other institution, organization or body.
- 6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination by elaws and the circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & examination by laws, directions issued from time to time and the law of the land.
- 8. That the school will ensure compliance of all statutory requirements like EPF, ESI. And labor laws etc., with respect to the school and staff of the school.
- 9. That the school will ensure that the Building Safety, fire Safety, Water Safety, Health and Hygiene certificates are being issued or renewed by the concerned municipal or star authorities from time to time as per the prescribed term.

The State Board School will be discontinued after switchover to CBSE.
